### Summary of reasons for decision:

The film Slumdog Millionaire was submitted on DVD prior to cinematic release in January 2009 and classified "Objectionable except if the availability of the publication is restricted to persons who have attained the age of 13 years", with the descriptive note "Contains violence and offensive language". This decision was registered on 20 January 2009. The version of the feature now submitted on a Blu-ray disc has a shorter running time but appears to be identical to the earlier version.

The extra material associated with the Slumdog Millionaire production gives no reason to alter the original decision. However, the Indian short feature Manjha, also on the Blu-ray disc, deals with sexual abuse in a manner that gives this component a high impact. The story of the abuse of a small girl is harrowing and her brother's revenge, resulting in the death of the abuser, is shocking. An already high level of emotional intensity is heightened by the use of black-and-white film stock. The extent of highly offensive language, used aggressively and in conjunction with dialogue explicitly referring to violent sexual acts, is a major component of the dominant effect of the short film. This material is likely to shock and distress children and younger teenagers. The explicit nature of many of the references may also have a harmful effect on the development of sexual behaviour and attitudes in young people who do not have the experience or maturity to deal with such material.

Because of the inclusion of the short film Manjha the original classification of Slumdog Millionaire requires alteration. A restriction to persons who have attained the age of 16 years is necessary to avoid injury to the public good. The descriptive note is also changed to reflect the presence of the short feature Manjha as one of the additional components on the Blu-ray disc.
